To Our Valued Customers,

Please be advised Conagra Brands, in cooperation with the United States Department of Agriculture (USDA), is conducting a voluntary product recall of 295,089 cases of select Armour Vienna Sausage and Potted Meat product. Some of the product may not meet Conagra's high-quality standards due to a potential defect with the can lid that could potentially compromise the integrity of the product.

The situation is limited to the impacted items and does not impact any other Armour or Conagra Brands products. There have been no reports of illness or injury due to the consumption of the products to date.
